

Usage regulations music & band rooms

Purpose

The music rooms are a service provided by VSETH and are available to eligible users for musical complementation of their studies or work.

Eligible Users

Primarily, the music rooms are available to students at ETH. Secondly, ETH employees, university students, and external individuals can make use of this offer. Using the music rooms for commercial purposes (e.g., offering music lessons) is not permitted. Failure to comply with these usage regulations will result in the revocation of usage rights.

Terms of use

Inventory

Users are obliged to handle instruments and equipment with care. Objects should not be placed on the grand pianos and pianos, and instruments should not be left in direct sunlight. Technical equipment in the band room (Room 5.2) must be protected from extreme temperatures and liquids. If an instrument/device is damaged, an immediate report must be made to VSETH (+41 44 632 42 98 or musikzimmer@vseth.ethz.ch), specifying the nature of the damage and room number. Only knowledgeable individuals are allowed to operate technical equipment in the band room. Compliance with equipment instructions in the band room is essential. Existing cabling must not be altered.

Volume

Playing loud instruments (acoustic drums, bagpipes, amplified guitars, etc.) is generally prohibited. The use of amplifiers and speaker boxes in the band room is allowed on weekdays from 6:00 PM to 12:00 AM and on weekends from 7:00 AM to 12:00 AM.

Order

All users should keep the music rooms clean by refraining from eating or drinking inside and taking all their waste with them. Music stands and chairs should be returned to their original rooms after use. The inventory of the band room (E-drum kit, microphone stands, instrument stands, mixing console, amplifiers and speaker boxes, and mounts) must not be removed from this room.

Reservation requirement

To use a music room or the band room, a reservation must be made online. During the reserved period, the user's badge will be activated for access to the booked room. It is mandatory to make a reservation because the hourly fee is billed based on the reservation.



Fee Structure

For every 6 months in which the music rooms are utilized, an enrollment fee will be charged. The amount can be found in the price list. This fee is due from the first usage. The first fee period runs from March 1st to August 31st, and the second one from September 1st to February 28th/29th. At the end of each respective period, the invoice for the past period will be issued. In addition to the enrollment fee, each booked hour will be billed. The hourly rates can also be found in the price list. The invoice at the end of a fee period includes the enrollment fee as well as the costs for each booked hour. The invoice is due within one month. Late payment may result in a reminder fee of 15 Swiss Francs per reminder. If usage fees are overdue, access to the music rooms may be blocked. The deposit will be frozen until the invoice is settled.

Fairplay and Consequences

If there is a violation of the usage or fee regulations, the VSETH reserves the right to take appropriate action. Especially in the case of damage to the inventory, the VSETH may claim compensation. Users should therefore take care not to damage the instruments and rooms, make reservations, and adhere to the fee regulations.

Access to Music Rooms

Each registered person receives a badge that allows access to the music rooms at the respective locations (Zentrum or Hönggerberg). A deposit of CHF 50.- is required for the badge, which will be refunded upon returning the badge.

Building Access

Users of the rooms at Hönggerberg can activate their student IDs for access after 9:00 PM on evenings and on weekends.
